



UPDATE: MARINE GUIDANCE FOR CLOTH FACE COVERS 4/29/20

As communities re-open, the virus may become more widespread – creating a higher chance of our essential workers becoming infected. The best ways to reduce the spread is everyone wear face coverings while still performing social distancing, washing your hands, and not touching your face. New data shows the virus can remain aerosolized for many hours. With widespread use, face coverings reduce aerosolization and droplet spread. The company now has face coverings in stock at the warehouse. The face coverings will be distributed in a controlled process. Anti-fog glasses are also available at the warehouse (see following list).

ALL MARINE EMPLOYEES

- Self-screen prior to coming to work
- Maintain social distancing – 6'
- All employees **must** wear face covering:
 - If unable to social distance
 - When working in close quarters with others
 - When in common areas or buildings with other occupants (e.g. MRF Shops, Float, Warehouse, break rooms, Annex offices, etc.)
 - When around others in the community during essential business travel (e.g. fuel stops, hotel check-ins, and at other facilities, etc.)
- Vessel employees **must** wear face covering at/when:
 - Crew change meeting and at crew switch; optional in crew vehicles but strongly encouraged
 - If in contact with any outside person while on vessel (dock, barge, etc.)
- Non-crew members **must** wear a face covering while onboard; crew members are strongly encouraged to wear face coverings while any non-crew members are onboard

CLOTH FACE COVER GUIDANCE

- Cloth face covers must be worn and cared for correctly or they could increase your risk
- Cloth face covers should:
 - Fit snugly but comfortably against the side of the face
 - Allow for breathing without restriction
 - Be machine washable and dryer safe
- Wearing a cloth face cover
 - Sanitize or wash your hands before putting the cover on your face
 - Do not touch the cover or your face while wearing
- Removing a cloth face cover
 - Remove the cover from behind to avoid touching the surface of the cover and your eyes, nose or mouth
 - Do not lay the cover on any surface, instead place it a plastic bag
 - Sanitize or wash your hands immediately and do not touch the cover again until it is clean
- Proper cleaning of cloth face covers:
 - Machine wash and dry at a high temperature
 - If available use a sanitizer such as bleach or Lysol
- Sanitize or wash your hands immediately after handling the cover
